Constitution Paragraph 3b

From:

"The AGM will be held after completion of the Summer League and before the commencement of the Winter League"

Constitution Paragraph 4c

From:

"Voting rights are defined in section 3.b.ii. General votes will be 1 per member. For election of committee members, voting will be 1 vote per team per committee vacancy."

To read:

"Voting rights are defined in section 3.b.ii. General votes will be 1 per member. For election of committee members, voting will be 1 vote per team per committee vacancy and for amendments to the Constitution, 1 vote per team."

Constitution Paragraph 6d

From:

"Minutes of these meetings will be published on the web site within 7 days of the meeting."

To read:

"Minutes of these meetings will be published on the web site within 7 days of agreement of the minutes by the committee."

Constitution Paragraph 8f

From:

"The rules of play will be the "Official UK 8 Ball Pool Rules" published by the United Kingdom Pool Federation 1992 with paragraph 4(e) changed to read "If no ball is pocketed from a legal break, then the player who breaks must clearly nominate his/her choice before play continues. Failure to do so will have the penalty of a foul.

This applies to all leagues, division and competition playing under the umbrella of Pompey Pool





League."

To:

"The rules of play will be the "Official UK 8 Ball Pool Rules" published by the United Kingdom Pool Federation 1992 with paragraph 4(e) changed to read If no ball is pocketed from a legal break, then the player who breaks must clearly nominate his/her choice before play continues. Failure to do so will have the penalty of a foul." and paragraph 4(d) changed to read "If one or more balls are pocketed from a legal break, the player who breaks must clearly nominate his/her choice of colour before play continues. Failure to do so will have the penalty of a foul". This applies to all leagues, division and competition playing under the umbrella of Pompey Pool League."

THIS WAS NOT AGREED.

It was agreed that rule changes should not be dealt with on a case by case basis but a general review of the rules of play should be undertaken later to consider all inputs from all Teams.

ACTION 1 – Dave Philpott to take this action back to the Committee and organise this review process.

Rules Paragraph 2g

Add "Additional players may not be signed on during the Summer Knockout Competitions."

THIS WAS UNANIMOUSLY AGREED.
